

Lifecycle Roadmap

All technology products eventually reach the end of their useful life requiring a business decision to discontinue availability and support. Every SupplyPro® product has a lifecycle roadmap that drives new technology and product innovation. The lifecycle begins when a product is released and ends when it's no longer supported. Knowing key dates in this lifecycle helps you make informed decisions about when to update, upgrade or make other changes to your hardware or software.

SupplyPro is committed to providing the highest quality products and services to our customers. As a technology developer and provider, we understand that our solutions allow our customers to establish and maintain competitive advantages, achieve operational efficiencies, and deliver the lowest TCO possible.

SupplyPro products qualify for technical support if the following criteria are met:

- Customers must stay current as per the servicing and system requirements published for the product or service, including fees and contractual requirements.
- Systems must be using the current release version.
- Customers must be licensed to use the product or service. SupplyPro updates are cumulative, with each update built upon all of the updates that preceded it; a device needs to install the latest update to remain supported.
- SupplyPro must currently offer support for the product or service.

MILESTONE	DEFINITIONS
End-of-Sale (EOS)	EOS, commonly referred to as End of Sale. The last date to order the product through SupplyPro sales. After this date the product is no longer for sale. As a general rule, SupplyPro will provide 6 months' notice of the affected product's end-of-sale date and/or the last day when the affected product can be ordered.
End-of-Service Life (EOSL)	EOSL, commonly referred to as End of Service Life. Essentially, it means that SupplyPro customer support will no longer be providing technical support, providing bug fixes, maintenance releases, workarounds, patches or selling spare parts after this date. It may be possible to get manufacturer support after an EOSL date, but this is on an as available, custom quoted basis. As a general rule, SupplyPro will provide 36 months from EOS to EOSL. The system may continue to function after the EOSL and function beyond the EOSL if SLF (Software License Fees) are current. Service contracts that have not been renewed or have lapsed after 12 months of end-of-sale date are not re-newable. Renewal of your service contract will generally be available until the last date of support, but will not extend beyond the last date of support.
End-of-Use (EOU)	EOU, commonly referred to as End of Use. The last day to use the product or service. After this date, all user activity will cease, active sites will be decommissioned; users will no longer have access to data. Data storage is determined by the customer sales agreement(s) and SupplyPro TOU (terms of use).
